HIGH SCHOOL SCHOLARSHIP PROGRAM

The **Valley Contractors Exchange Scholarship Program** was established to provide financial assistance to our members' high school seniors, who are continuing their education in college or trade school.

ELIGIBILITY

The program is open to graduating seniors whose parent/guardian is an owner or employee of member firms in good standing. A written recommendation from the owner or a key-employee must be submitted with the application. Scholarship awards are available for high school seniors entering a university, college, community college or trade school within 1 academic year of graduation. **Applicants must have a minimum GPA of 3.00 over the last three years of high school.**

BASIS OF AWARD

Awards will be based on transcripts (GPA), achievements and leadership qualities. Finalists may undergo a personal interview. The amount of money available will be determined at the time a recipient is chosen. Scholarship money will be distributed directly to the student upon receiving proof of enrollment and tuition payment for the Fall 2024 semester.
